We provide this information in order to respect our commitment to communicate the applicable law and to ensure your privacy on our website www.hp.elettron.net
These terms and conditions provide information about the type of cookies we use and how to manage, control or eliminate them.

Type of cookies used by www.hp.elettron.net

Functionality Cookies

From the first access these cookies allow the site to work correctly and allow you to view content on your device, recognizing the language and the country from which you choose to connect. Functionality cookies are essential, as they enable you to move around the site and use its features.

Performance Cookies

These cookies are used for statistical analysis about users' navigation on our site. ELETTRON Progetto Energia s.a.s. di Rossi Mario & C. treats the results of this analysis anonymously and exclusively for statistical purposes and only if the service provider uses cookies in connection to the browser or other devices used to surf the site.

The site uses some third-party services that, in a completely independent way, install their own cookies.

PRIVACY POLICY

According to art. 13 del d. lgs. 30 giugno 2003 n. 196 ("Codice Privacy"), this informative note describes how ELETTRON Progetto Energia s.a.s. di Rossi Mario & C. treats users' personal data received via its website www.hp.elettron.net and others, with the exclusion of external links.

Data controller

The owner of personal data is ELETTRON Progetto Energia s.a.s. di Rossi Mario & C. based in Stradone Farnese, 14 - 29122 Piacenza, Italia.

Categories and nature of data processed

ELETTRON Progetto Energia s.a.s. di Rossi Mario & C. will process personal data collected during the navigation and use of the site, as well as at the time of registration, where filling in forms and requests have been made, through electronic and automated systems.

Purposes

Personal data may be processed for the following purposes:

- a) performance of obligations closely related to the use of the site, the registration and the access to restricted areas of the same;
- b) respond to specific requests;
- c) comply with legal obligations;
- d) The data collected will be used for commercial and informative purposes.

Mandatory or optional nature of providing data and consequences of any refusal

With regard to the purposes indicated in points a), b) and c), the provision of your data to ELETTRON Progetto Energia s.a.s. di Rossi Mario & C. is mandatory and processing does not require your consent.

Any refusal to provide the data will make it impossible for ELETTRON Progetto Energia s.a.s. di Rossi Mario & C. to process any requests.

Processing methods

Personal data are processed by automated tools, strictly related to the purposes, for the time necessary to achieve the purposes for which they were collected or to comply with any legal obligations.

Specific security measures are taken to prevent data loss, misuse or incorrect and unauthorized access. The information collected is stored in a safe environment.

Disclosure of data

Personal data will not be disclosed and may be communicated in Italy for the purposes of the above, to third parties acting on behalf or in the name of ELETTRON Progetto Energia s.a.s. di Rossi Mario & C., such as those designed to treat the relationship with customers, lenders, our consultants, outsourcers, etc.

For the aforementioned purposes the data may be shared with the staff designated by ELETTRON Progetto Energia s.a.s. di Rossi Mario & C. or its treatment managers.

An updated list of controllers is available at the headquarters of the company.

Rights of the person concerned

We inform you that the Privacy Policy confers the exercise of specific rights.

In particular, at all times, you can get: a) the confirmation of the existence of personal data concerning him or her, even if not yet registered, and their communication in intelligible form; b) the origin of personal data, the purposes and methods of treatment and the logic applied in case of treatment with the help of electronic instruments; c) an indication of the owner and managers personal information and the persons or categories of persons to whom the data may be or who may become aware; d) the updating, rectification, data integration, as well as

the cancellation, transformation in anonymous form or blocking of data processed unlawfully, including data which need not be kept for the purposes for which the data were collected or later triet; e) confirmation of operations referred to in subparagraph d) have been brought to known, also regarding their content, of those to whom the data were disclosed, except where such compliance is impossible or involves a use of tools clearly disproportionate to the protected right. The person providing the data, according to art. 7 of the “Codice Privacy” is also entitled to object, for legitimate reasons, processing of personal data, even if relevant to the purpose of the collection, as well as to processing of personal data for the sending of promotional communications or other the purposes for which it has issued consent.
